- Property Consigned:** designXchange acknowledges receipt of goods as described on the "Inventory List". Said goods shall remain property of Consignor until sold. Consignor certifies that they have the legal right to all items consigned and agrees that all items are saleable and/or free and clear of liens or other claims.
- Efforts to Sell:** designXchange, at its own cost and expense agrees to keep and display the goods at its place of business and attempt to sell them at or above the agreed prices. designXchange will obtain the consent of Consignor before selling the goods at prices lower than those previously agreed upon in writing below.
- Proceeds of Sale:** designXchange agrees, upon sale, to maintain proceeds due Consignor in trust, and separate and apart from its own funds and deliver such proceeds, less commission, to Consignor. This will occur on the 15th of the month following the month in which the goods are sold. Checks will be issued automatically on accounts earning \$20.00 or more. Accounts earning under \$20.00 will be accumulated until it reaches \$20.00. Checks are available for pick up at designXchange. Consignors are responsible for retrieving all checks issued from designXchange. Checks issued are valid for six months and will not be reissued or refunded if not cashed within those six months.
- Commission:** designXchange agrees to accept as full payment a 50% commission based on the gross sales price exclusive of any sales tax. A small processing fee will be added to every consigned item in the store. This amount is not subject to the 50/50 split and is considered a processing fee paid by the buyer of the item.
- Ownership of Goods:** designXchange acknowledges that title to the goods shall remain with Consignor until goods are sold in the ordinary course of business. Items not sold within 90 days may be picked up by the Consignor without commission payment. Items are to be picked up within the following 10 days or will be considered abandoned, becoming the property of designXchange and may be disposed of, donated, or sold at the discretion of designXchange.
- Risk of Loss:** While the goods are in designXchange's possession, Consignor will bear the risk of damage to or loss of the goods. If the goods are damaged or lost, designXchange will notify the Consignor immediately of the circumstances regarding the damaged or lost goods.
